

# **BYLAW NO. 783(A)**

OF THE  
TOWN OF KILLAM  
IN THE PROVINCE OF ALBERTA

**BEING A BYLAW OF THE TOWN OF KILLAM, IN THE PROVINCE OF ALBERTA, FOR THE PROVISION OF ESTABLISHING RATES FOR WATER AND SEWER SERVICE IN THE TOWN.**

**WHEREAS** the council of the Town of Killam deem it necessary to make provision for the levying and collecting of certain rates or charges to meet the cost of maintaining and operating the said water supply and distribution system;

**WHEREAS** the Council of the Town of Killam considers it necessary to amend Bylaw No. 783, and

**WHEREAS** the Council has the authority pursuant to the provisions of the Municipal Government Act, Revised Statutes of Alberta, 2000, Chapter M26, to amend the said Bylaw No. 783

**NOW THEREFORE** the Council of the Town of Killam, duly assembled, enacts as follows:

**THAT** the Bylaw No. 783 be hereby amended as follows:

## **DEFINITIONS**

1. In This Bylaw;
  - (a) “single family dwelling” is defined as permanent family lodgings as follows:
    - free standing single housing
    - living quarters forming part of a commercial building, institution such as a church, school, etc.
  - (b) “Town” is defined as the Town of Killam.
2. That water service charges are payable monthly and are included in a monthly utility bill, showing separate charges for gas, water and sewer services.
3. That every person, firm or corporation being the owner or the occupant of property which is served directly or indirectly by a connection with the water supply and distribution system of the said Town of Killam, shall pay monthly to the said Town, the water and sewer rates as set out as follows:

All water consumption in excess of the maximum metered water consumption per month is subject to an additional \$1.00/m<sup>3</sup> penalty charge over and above the regular per monthly water rate, plus service charge.

Any and all Classification per customer is subject to change by motion of Council.
