“SECTION 46: Objects Prohibited or Restricted in Yards

46.3 No occupant of a principle dwelling in a residential district shall permit a recreational vehicle to be used for living or sleeping accommodation for longer than 14 days during a 365 day period and that there must be 20 days in between each time it is used for sleeping accommodations.”

There was no desire of Council to amend this Section.
