**BYLAW NO. 844:
NUMBER OF
COUNCILLORS** Mayor James introduced the bylaw and explained the intention of the proposed bylaw. A draft copy of Bylaw No. 844, Number of Councilors and the Chief Elected Official (Mayor), is hereto attached and forms a part of the minutes.

BYLAW NO. 844, BEING A BYLAW OF THE TOWN OF KILLAM IN THE PROVINCE OF ALBERTA FOR THE PURPOSE OF PROVIDING THE NUMER OF COUNCILORS AND THE ELECTION OF THE CHIEF ELECTED OFFICAL (MAYOR) IN ACCORDANCE WITH SECTION 143(2) OF THE MUNICIPAL GOVERNMENT ACT, RSA 2000, CHAPTER M-26, AS AMENDED.

THAT under authority of Sections 143(2) of the Municipal Government Act, being Chapter M-26.1 of the Revised Statutes of Alberta 2000 and amendments thereto, it is the intention of the Town of Killam to seek input regarding the introduction of Bylaw 844 whereby

- 1.** The Municipal Council of the Town of Killam shall consist of five (5) council members, one of which is the Chief Elected Official.
- 2.** That the Chief Elected Official shall remain to be elected by the eligible electors of the Town of Killam as a whole.
- 3.** The Chief Elected Official shall have the same term of the other councilors.
