## **BYLAW NO. 719**

## OF THE TOWN OF KILLAM

## IN THE PROVINCE OF ALBERTA

BEING A BYLAW OF THE TOWN OF KILLAM FOR THE PURPOSE OF LICENSING AND REGULATING NON-RESIDENT HAWKERS, PEDDLARS AND TRANSIENT SALESPERSONS.

WHEREAS pursuant to the Municipal Government Act, being Chapter 26.2 of the Statutes of Alberta, 1994, and amendments thereto, the Municipal Council of the Town of Killam, in the Province of Alberta duly assembled enacts as follows:

- 1. This Bylaw shall be known and may be cited as the "Business Licensing Bylaw" of the Town of Killam.
- 2. No non-resident person shall conduct door to door or street vendor sales within the limits of the Town of Killam, unless or until he has paid the prescribed fee as set out hereto, and holds a valid and subsisting license issued pursuant to the provisions of this Bylaw.
- 3. A license fee may be imposed upon and shall be paid by all non-resident hawkers, peddlars and transient salespersons, prior to the commencement of any sales activities within the limits of the Town of Killam.
- 4. Persons, firms or corporations licensed under provisions of this Bylaw shall be subject to inspection at all times by any duly authorized officer of the Town of Killam.
- 5. The Council of the Town of Killam may at any time revoke or suspend any license issued under the provisions of the Bylaw for failure to comply with any conditions or regulations herein.
- 6. Whenever a license is issued subject to certain conditions, it shall be endorsed on the license the particulars of such conditions.
- 7. All license fees paid under the provisions of this Bylaw shall be credited to the general revenue of the Town of Killam.
- 8. Any person, firm or corporation violating any provisions of this Bylaw shall be liable upon summary conviction to a fine of not less than \$50.00 and not more than \$100.00 exclusive of costs, and in default of payment of fine and costs, in the case of a person, to imprisonment for a term not exceeding thirty days.
- 9. The fees for non-resident hawkers, peddlars and transient salespersons shall be:

\$20.00 per day \$50.00 per quarter (3 months) \$150.00 annually (12 months)

- 10. This Bylaw will be in effect upon third reading and final passage.
- 11. Bylaw No. 580 is hereby rescinded.
